- In the event FHG Fueling extends credit to customer, its acceptance of order(s) is made conditional on customers' terms and conditions of this credit application. The terms and conditions set forth in this credit application will govern all transactions between customer and FHG Fueling. The terms and conditions of purchase order(s) and other similar documents submitted by the customer will not become part of an agreement with FHG Fueling unless FHG Fueling accepts it in writing.
